

Corpus Christi Stewardship Commission Minutes

October 10, 2018

Prayer: The meeting opened at 6:35 pm

Meditation: Bob Ruh provided the meditation taken from the 3rd Glorious Mysteries of the Rosary. Tom Pawlak agreed to provide the November meditation.

Handouts were provided for review September 12, 2018 minutes, Parish Council minutes, Section 4, Stewardship, "Lay Witness Presentations," "My Ministry Commitment to Corpus Christi Parish, The "Stewards in Action" October 2018 edition on the Stewardship Fair and the November 2018 edition on Music Ministry. Appreciation expressed to Mark for his work on the bulletin inserts.

Parish Council Minutes: Mark discussed the Parish Council interest in the Stewardship Fair.

Old Business: Members reviewed the "My Ministry Commitment" and determined it was ready as is. Discussion regarding the details of the Stewardship Fair with the following to be implemented:

1) Stewardship Weekend will be held the weekend of October 27 & 28 after all masses.

It will include:

- a. Hosting tables in the gathering spaces after all masses.
- b. Stewardship Fair in Parish Hall after all Masses with coffee and donuts. Group the tables to facilitate volunteer leaders' ability to discuss and showcase several ministries. Liana will adjust the database to reflect the groupings of Liturgy, Christian Service, Faith Formation and Administration.
 - i. Tables to be set up so that those coming into the Parish Hall will walk in front of them on their way to coffee and donuts.
 - ii. A sign-up sheet and ministry identity sheet will be clearly marked on each table. Samples were reviewed and approved.
 - iii. Yellow Directories of Corpus Christi Ministries will be available on each table.
 - iv. A packet of information will be emailed or sent to all ministry coordinators. The packet should include detailed information about the Fair and identifying those volunteers who will man the tables to discuss their ministries and answer questions. If there is hand out material beyond what is in the directory, they may also include it on their table.
- c. Include the "My Ministry Commitment to Corpus Christi Parish" pamphlet in bulletin for parishioners to fill out and return to parish office or in offering baskets during mass.
- d. Mark will contact Fr. Bob with announcements to be included in the October 24, 25, 27, and 28 masses.

New Business: Mary Ann discussed the diocese request for 2018-19 Commission goals. The following goals were discussed by members present:

1. Increase membership on the Stewardship Committee.
2. Institutionalize the Stewardship Fair as an annual event at Corpus Christi Parish.
3. Increase activities to promote 'community' at Corpus Christi (merged) Parish. ie friendships, caring relationships among parishioners

Plan:

1. Liana will update ministry database and email new list to committee members.

2. Liana will create Stewardship Fair packet check list for ministry coordinators and send to committee members. Packet to include: check list. "My Ministry Commitment to Corpus Christi Parish." A Directory of Ministries, and the bulletin insert for October.
3. Mark will make follow-up phone calls to all ministry coordinators to clarify packet information and compile the list of volunteers for each gathering space at mass, and fair tables for each mass.
4. Mary Ann will send out packets to all Ministry Coordinators.
5. Mary Ann will facilitate the table set up for the fair.
6. All Stewardship committee members will sign up for the gathering space or the Parish Hall Stewardship Fair.
